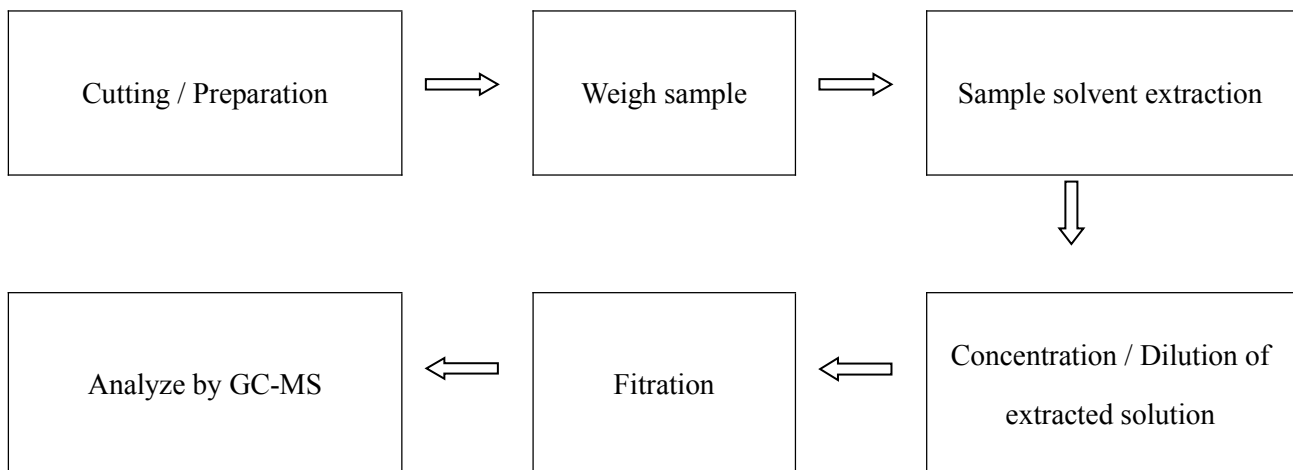
Nonmetal material

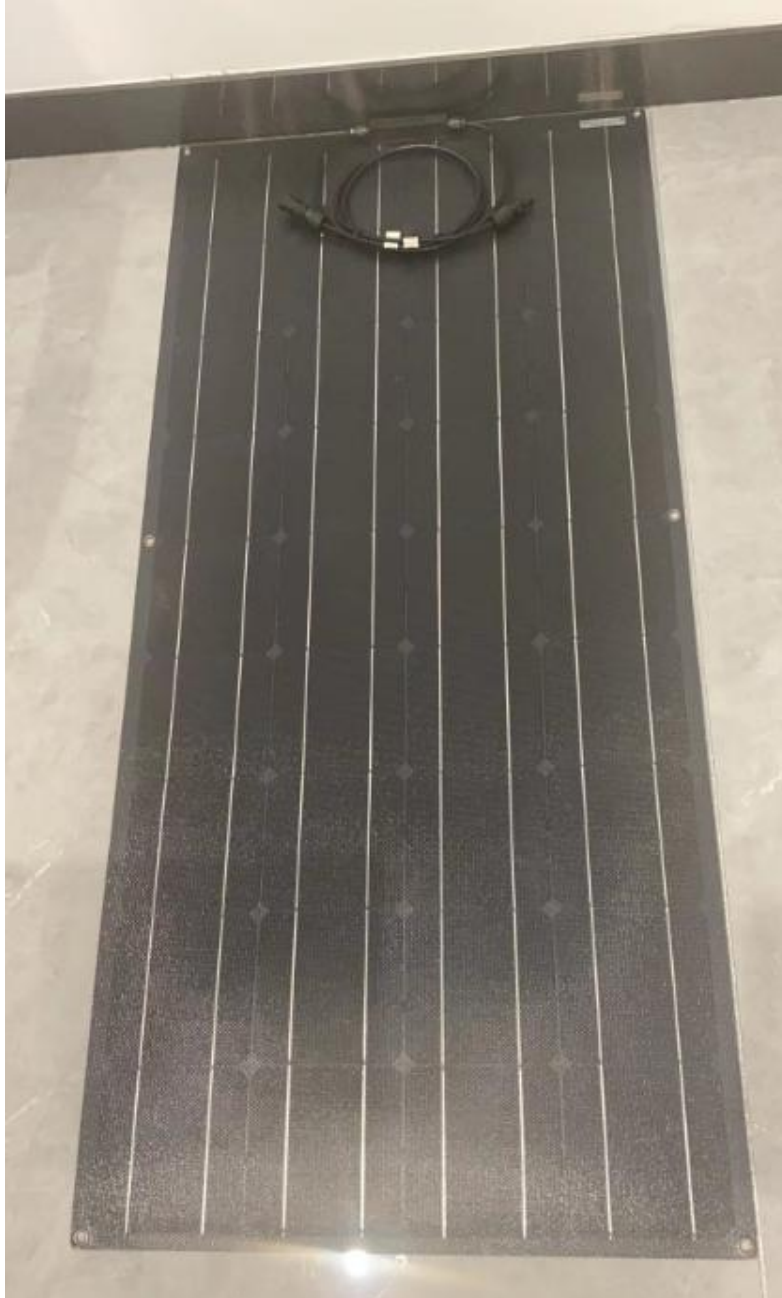
